#### 1. ORGANIZATION INFORMATION

In March 2009, from initiative by activists of several Roma NGOs from Republic of Macedonia was established InSoC - Initiative for Social Change.

#### The InSoC vision is:

Roma live as socially equal actors in society, ASCEND individuals and society as a whole.

The ASCEND to which InSoC weighs means raising the value of each individual in society and society as a whole through a social change aimed at the sustainable development of democratic values, the rule of law, human rights and human capital.

InSoC members agreed to work jointly towards achieving the Mission:

# We actively contribute to social change and a just society.

Activities for social change and equitable national development are the based of a just society that involves the work of changes in the social structure of society, patterns of social behavior and social relations, social groups and individuals, as well as normative changes in the direction of upgrading the values of each individual in society and society as a whole.

# The objectives of InSoC are:

- Encourage partnerships and good cooperation between Roma NGOs and state institutions for social inclusion of Roma in the period 2014-2020.
- Strengthening the capacity of Roma NGOs to access EU funds and other bilateral funding opportunities.
- Advocating for greater inclusion of Roma in accordance with the EU2020 guidelines.

- Each person achieves the maximum possible individual development.
- Society composed of self-realized individuals to function harmoniously and in the direction of sustainable joint development.

InSoC works on social change in the social structure, organization, institutions, behavior, relationships and movement. In its work, InSoC applies the identified activities of active citizenship: observation and analysis, reporting, promotion, education, motivation, direct services, advocacy, networking, communication, negotiation, mediation, information, etc.

InSoC applies innovative and modern approaches that include artistic, scientific, media and other approaches to work. In its work, InSoC realizes the values it promotes - democracy, rule of law, human rights, human capital.

InSoC has a rights-based approach that includes a direct link to human rights, job responsibilities, empowerment of individuals and groups and their participation in work and equal opportunities, with a particular focus on vulnerable groups, especially Roma.

InSoC was established by experienced civil society and human rights activists with many years of experience working on issues related to Roma. People who are involved in InSoC are well known as Roma civil society activists and local-level experience of the Roma community, research, training, support, and other types of activities. For example, InSoC employees were involved in the creation of public policies targeting Roma in the Republic of Macedonia, that is, the National Strategy for Roma and the Action Plans of the Decade of Roma Inclusion 2005-2015, including the revised plans. InSoC is engaged by the Ministry of Labor and Social Policy to facilitate and provide technical assistance for the preparation of local action plans for the Decade of Roma Inclusion 2005-15, in several municipalities in Macedonia.

Regarding the organizational knowledge of Roma issues in Macedonia and beyond, InSoC has actually played a key role in the monitoring program called DecadeWatch Macedonia, followed the implementation of the Decade of Roma Inclusion 2005-15, and the InSoC team was involved in national and international activities related to this policy. Therefore, InSoC has in removing almost all relevant available information related to the Decade of Roma Inclusion 2005-15, as well as in relation to the National Roma Strategy.

The InSoC team was involved in a number of other surveys and reports, and have a great deal of information on the overall situation of Roma in Macedonia, such as: UNDP Surveys, REF Analysis and Strategy for Macedonia, micro study on employment policies Roma, ECMI-ROM reports on education, employment, health and human rights, a regional minority study discourse within the EU accession process, a regional study on the participation of minorities in financial flows associated with the assessment of EU accession.

In 2011, InSoC was a contact point for the ROMED project, which is supported by the Council of Europe. InSoC coordinated 30 local mediators from 4 municipalities, representatives from local institutions.

As part of the overall efforts to reduce poverty among Roma, the Initiative for Social Change - InSoC started the implementation of the "Model of Roma mediators" project, funded by the Open Society Institute - Budapest Institute. The project aimed to increase the access of Roma representatives to the local self-government units and to help local Roma communities become active users of public services at the local level



by developing a model for Roma mediators. The project was designed in a year and focused on 3 municipalities, to serve as a model for other municipalities.

In 2012 and 2013, InSoC's activities were aimed at increasing advocacy efforts. The realized projects for this period were: "Municipal governance and inclusion of Roma in Europe - Lessons from the field" with this project InSoK promoted the activities of the municipalities in the Republic of Macedonia; The project "Civil Society Monitoring for Implementation of National Roma Integration Strategies and Decade Action Plans" provides an impact on the social community in order to effectively implement public policies targeting Roma in the Republic of Macedonia; The project "Political representation of Roma in UN agencies and EU institutions", which was an advocacy initiative to create greater representation of Roma in EU institutions and UN agencies.

InSoC has developed excellent cooperation and relationships with a number of relevant stakeholders regarding Roma issues, including national and local authorities, non-governmental organizations and the international community, and is part of several civil society networks.

The InSoC team was consulted on the planning of project activities for IPA 2008, IPA 2009 and IPA 2010 Component 1, 2009-13 and IPA Component 4, especially important for Roma issues. They are also consulted on other EU-funded programs, such as EIDHR 2010 for Macedonia. Civil Society Action Program 2015 / Instrument for Pre-Accession Assistance (IPA) Europe Aid / 151569 / DD / ACT / MK, RIO - Budapest, USAID and others.

In addition, InSoC employees were consulted on project fiches and projects funded by the EU in relation to Roma issues. InSoC provided technical assistance to certain state authorities for projects that were planning their development.

# Title: DECADE WATCH MACEDONIA - HALF WAY OF THE ROMA DECADE

**Supported by:** Foundation Open Socety Institute Фондација Институт Отворено Општество (ИОО-Zug), part of the network of the Soros Foundations

**The overall aim** of the project is to improve the situation of Roma in Macedonia and Roma Decade Region by improving the implementation of the Roma Decade through monitoring and advocacy and increased involvement of Roma in the Roma Decade.

To contribute to the project aim, the following objective shall be achieved through the project implementation:

- 1. To continue and strengthen Roma Decade monitoring and advocacy efforts of the Roma civil society in order to further improve the implementation of the Roma Decade.
- 2. To create useful and user friendly Roma Decade resources and Roma community involvement mechanisms in Macedonia.

#### **Expected results:**

- 1. Positive changes in the implementation of the Roma Decade in Macedonia (such as increased budget, more active stakeholders, new programs, etc).
- 2. Increased monitoring and advocacy capacities among Roma activists, particularly those involved in the project.
- 3. National monitoring data-base and general Decade resources created and input into regional monitoring and advocacy efforts made.
- 4. Local Roma communities involved in the process of monitoring and information sharing.

#### Target group/ Beneficiaries:

Final beneficiaries of the project are 54.000 Roma or 2,66% from the overall population of the Republic of Macedonia.

#### Direct project's beneficiaries:

• Project team that include 3 persons and 10 moitors.

**Indirect target group:** State and local-self government, CSOs, Roma polititians, media, international organizations as EU, Council of Europe, OSCE, UN etc., regional Decade Watch team, roma community from 10 municipalities where the information will be collected and will be include in the meetings.

#### **Project activities:**

- 1. Advocacy on national level

**Project sustainability:** The project introduces a number of innovations for implementation and monitoring of the Decade of Roma. The project is expected to make efforts to disseminate information, but also requires efforts by the entire civil society, in particular the Open Society Institute and the Roma civil society in the countries participating in the Decade. The project will create a structure and procedures for monitoring the Decade, as well as mechanisms for consultation, representation model of activities. Activists involved in the project will enhance the capacity of their procedures and structures for monitoring will be created diverse and adequate resources. This is one aspect of sustainability of the project that will remain after completion of the project.

**The overall aim of the project is:** Developing democratic approach to the work of public administration working on Roma-related policies.

To contribute to the project aim, the following objective shall be achieved through the project implementation:

- 1. To develop an information management and institutional memory for the system of public administration working on Roma-related policies. Collection and management of information about the situation of Roma.
- 2. To develop a communication strategy on public administration thet works for the needs of Roma. Mapping of relevant stakeholders and defining the ordinary and extraordinary procedures, channels of communication and sharing of information.
- **3.** To establish the basic organizational and dokumentacional practice of transparency and accountability of public administration working on Roma-related policies.

#### **Expected results:**

The project is designed to create the necessary basis for transparent and accountable policy and initiate regular processes, particularly in terms of regular communication and participation of Roma community policies which are aimed at that. Moreover, the project was designed in coordination and with the support of the Ministry of Labour and Social Policy. As such, it guarantees the continuation of established procedures, processes and responsibilities in the project. The project has embedded programming, institutional and financial sustainability. Furthermore, InSoC is committed to working on this issue in the future as well, meaning that it will support Roma-related policies and processes to ensure proper entry of their implementation.

The target group of the project are: employees from the Department of Roma policies in the Ministry of Labour and Social Policy, where are working 5 Roma and 8 Roma Information Centres (RICs).

Through project development assistance, training, and advocacy, PGF seeks solutions to problems such as weak visibility of Roma issues at local level, resource and expertise disadvantage, and overly bureaucratic funding procedures, which block access of the most deprived to development opportunities.

# CENSUS OF THE AWARENESS OF THE ROMA IN MACEDONIA

**Supported by:** Foundation Open Society Institute (OSI-ZUG)

#### **Goals and Objectives:**

- To inform, motivate, and encourage at least 8,000 Roma from Roma settlements in western Macedonia to freely declare themselves as Roma in order to meet the civil right that belongs to them. And to encourage to overseein the census not to put in risk of incorrectly counting of the Roma community.
- To cooperate with stakeholders (State Institute of Statistics, more intensive cooperation, the Ministry of Interior and local governments) for proper implementation of the Law on Census.

#### **Title: MODEL ROMA MEDIATORS**

Supported by: Open Society Institute and the Council of Europe

#### Purpose:

The project aims to increase access of Roma community to the local public services in selected municipalities, using the model of Roma mediators.

#### Expected results:

Roma mediators will act as a link between the Roma communities and local public services, facilitate Roma access to public services and taking actions to make local public services more accessible for Roma, by sharing information, providing contacts, facilitating communication to language and cultural differences, identifying patterns of barriers to access to public services, the preparation of analysis and proposals for improving public services.

#### Target group / users:

Final beneficiaries of the project are 54,000 Roma, or 2.66% of the total population in Macedonia.

#### The direct target group of the project are:

83 municipalities in Macedonia, project team InSoC, 3 mediators

Advocacy efforts aim at changing the political practice of the Decade of Roma in Macedonia. Although it will be difficult to achieve sustained political change during the one-year project and is difficult to make assumptions on what changes will take place because it is not under the control of the project and previous experience showed flow changes are possible and appropriate to the objectives of project. Some of the examples show that through monitoring and advocacy efforts of Macedonia started to allocated funds for implementation of the Decade of Roma, recently revised action plans in order to improve quality, the inclusion of Roma in the political and practical level is increased.

- It is expected that the project will start early April 2013 and last for 8 months, until November 2013. The first month will be used for the initial phase, 6 months conducting research, and 1 month to finalize the study and project. During the survey period, at least three drafts of the study are expected by the researcher Sustainability of the project:


