(Overall objective), Impact

Strengthening regional Roma inclusion in the Western Balkans through policies and initiatives addressing economic disparities, combating antigypsyism, and promoting social integration.

(Specific objective(s), Outcome(s)

- R1: Establish a cohesive and well coordinated Regional Network of Roma CSOs
- R2: Targeted economic empowerment initiatives in WB leading to measurable improvements in the economic conditions of Roma communities across the region
- R3: Establish a collaborative regional network that boosts awareness and action against antigypsyism at regional and national levels through effective advocacy

Outputs:

- O1.1 Regional Policy Network Hub for Roma inclusion policies established and promoted
- O1.2 Robust monitoring of EU sectoral reforms related to Roma, central government policies, service delivery, and budgets for Roma inclusion, conducted in at least 5 countries; reports published and disseminated
- O1.3 Specific priorities and needs of Roma communities identified by the active citizen networks, advocated, and included in the central government policies and donor priorities for the next period
- O1.4 Established regional platform for donor cooperation (EU, USAID, World Bank, UNDP, SDC and other donors)
- O1.5 Three trainings on advocacy and networking were organized, with at least 20 participants per training.

- A.2.2.2 Initiate discussions and establish partnerships with businesses to understand their workforce needs and explore collaboration opportunities.
- A2.2.3 Develop a comprehensive database of skills and competencies within the Roma community, aligning them with the job requirements identified by local businesses.
- A2.2.4 Facilitate job matching and placement services, connecting qualified Roma individuals with suitable job openings and providing support throughout the application and hiring process.
- A2.2.5 Collaborate with government agencies to advocate for inclusive hiring policies by providing incentives to companies to hire Roma.
- A2.3.1. Assess the feasibility of different piloting models, considering the skills, resources, and preferences of Roma communities in each targeted economy.
- A2.3.2 Engage with local communities, fostering a participatory approach to the establishment of community cooperatives, social enterprises, and business start-ups.
- A2.3.3 Advocate for supportive policies at the local and national levels, working with governmental and non-governmental stakeholders to create an enabling environment for Roma economic empowerment.
- A2.3.4 Provision of grants to set up pilot initiatives in national economies within the Western Balkans, tailoring the economic models to the specific needs and opportunities of each community.
- A2.3.5 Facilitate networking opportunities by connecting entrepreneurs with experienced mentors, industry experts, and potential collaborators.
- A3.1.1 Conduct a comprehensive review of existing legislation to identify gaps and areas where antigypsyism is not adequately addressed.
- A3.1.2 Formulate reform proposals to integrate explicit references to antigypsyism in relevant legal frameworks, ensuring legal provisions that safeguard the rights of the Roma community.
- A3.1.3 Facilitate policy dialogues and consultations with relevant government agencies, legislators, and advocacy groups to discuss the incorporation of antigypsyism recognition into policies.
- A3.1.4 Training sessions for policymakers, legal experts, and government officials to deepen their understanding of antigypsyism.
- A3.1.5 Provide resources, such as informational materials and case studies, to enhance their capacity to recognize and address antigypsyism in the formulation of policies and legislation
- A3.2.1 Conduct ongoing research to gather data on instances of antigypsyism, discrimination, and challenges faced by Roma communities.
- A3.1.2 Compile the collected data into comprehensive reports that analyze the prevalence of antigypsyism, its manifestations, and its impact on the social, economic, and cultural aspects of Roma communities. A3.13. Dissemination of the report using various communication channels
- A3.1.4 Collaborate with advocacy groups and civil society organizations to build support for policy changes addressing antigypsyism and promoting the rights and inclusion of Roma communities.
- A3.3.1 Develop a comprehensive plan outlining the objectives, agenda, and logistics for stakeholder engagement conference at regional and national levels.
- A3.1.2 Identify and compile a list of key stakeholders, including government officials, representatives from NGOs, community leaders, and relevant experts.
- A3.1.3 Design an interactive and inclusive agenda that encourages open dialogue, collaboration, and information exchange among participants.
